

 TABS met with representatives of the HSA, MED, and TECH JCSGs on 30 March to integrate the Candidate Recommendations (CRs) impacting Walter Reed (HSA-0106, MED-0002, 0024, 0029, and TECH-0032). It is our understanding that the JCSG representatives had no issues with the requested changes or updates. The results of the integration effort are attached.

The information in the attached memorandum contains data inputs for Army installations. These inputs have been certified by the appropriate certification authority, in accordance with our Internal Control Plan. The Army does not certify JCSG provided unit space and personnel requirements that are used within these CRs.

No changes to the these terms and conditions may be made unless previously agreed to between Vendor and DIR.
